

The Finals Rules:

mychoice Big Game Tickets Giveaway

(The Big Game Finals Drawing)

OFFICIAL RULES (“Official Rules”)

OPEN ONLY TO LEGAL RESIDENTS OF THE 50 UNITED STATES AND THE DISTRICT OF COLUMBIA, 21 YEARS OF AGE AND OLDER WHO ARE SELECTED FROM EACH OF PENN NATIONAL GAMING INC. (PNGI) REGIONAL PLAYOFF DRAWINGS. THIS PROMOTION IS INTENDED FOR ENTRY IN THE UNITED STATES ONLY AND WILL BE CONSTRUED AND INTERPRETED UNDER THE LAWS OF THE UNITED STATES. 1. Participation in The Big Game Finals Drawing (“The Finals”) is limited to a maximum of forty (40) people.
2. The Finals will be comprised of a maximum of ten (10) winners from each of the four (4) Regional Playoff Drawings: West, East, North and South that will be held in January 2022.
3. Registration for The Finals drawing will be held on Friday, February 4, 2022, from 2:00 p.m. to 8:00 p.m. and Saturday, February 5, 2022, from 9:00a.m. to 1:00p.m. Pacific Standard time at M Resort. Participants must register in person (**Failure to register during these times will result in disqualification**).
4. Participants will receive their drawing entry at registration and must place it in the drawing drum by 3:59pm Pacific Standard Time on Saturday, February 5, 2022.
5. The Drawing drum will be closed at 4:00pm Pacific Standard Time on Saturday, February 5, 2022. No additional Drawing Entries will be allowed to be placed in the drum after this time.
6. The Finals Drawing will take place at 8:00pm Pacific Standard Time on Saturday, February 5, 2022. Participants must be present to win. 4 tickets will be drawn from the drum. The winning names will be announced, and the winners will be given 2 minutes to claim their prize. If not claimed within the timeframe; participant forfeits prize and the next ticket will be announced. The first ticket drawn will be the 4th place finisher, the second ticket drawn will be the 3rd place finisher, the third ticket drawn will be the 2nd place finisher, and the fourth and final ticket drawn will be the grand prize/1st place winner. The prizes for each place are as follows:
 - i.) 1st Place Grand Prize: 2 Big Game tickets, 3 nights hotel accommodations and game day transportation to/from the hotel and the stadium on February 13, 2022, AND 2 million Choice Privileges® points† AND a single cash payment of \$250,000. (Cash payment is equivalent to the discounted lump sum of the approximate value of 2 Big Game Tickets, airfare and room accommodations for 24 years.) Winner may choose between the 2022 Big Game Event or \$15,000 in cash; winner will be given up to 24 hours to choose prize payout.

7. **mychoice** Big Game Tickets Giveaway Finals prizes are non-transferable and must be redeemed at the Casino Cashier's Cage at M Resort by noon PST on Tuesday, February 8, 2022.

- a.) Must be twenty-one (21) years of age or older.
 - b.) Must provide valid U.S. or state government issued personal identification document with photo and proof of age. Participants who are not U.S. citizens must provide a current passport or alien card registration.
 - c.) Must present their **mychoice** Rewards card and be a cardholder in good standing. Mychoice Rewards cards are free and are available at participating PNGI casinos.
 - d.) Must not be subject to any current exclusion list at M Resort Spa Casino or any other PNGI gaming facility (whether through a government exclusion program, an internal casino exclusion directive, or the Participant's own exclusion request).
9. The Finals are subject to all applicable federal, state and local laws and regulations, including regulations of the Nevada Gaming Commission.
